Sound in the arenas needs tested, internet will be updated August 5, we will make sure Dr Morley is available for vet checks, July 24 pre fair meeting barbecue, FFA is bringing grills to make hamburgers and hotdogs, Dena will remind the superintendents. Tiffany wants to know if the swamp coolers have been serviced and the lights have been checked. Sale committee would like the coolers turned on earlier for the Monday night sale.
